She believes that we need to reinstate the interventionist at Luce with the ESSER II grant that South Spencer will be receiving.

We have lost two teaching positions that retired or resigned and were not replaced. We are being told that we are going to go down 3 more teaching positions. This makes for larger classroom sizes and less being offered. The plan was made before knowing about the ESSER II grant and the teachers feel like they are not being heard.
